


Installation Guidelines

- May be subject to Australian Building Code Regulations for height and location fixing and may be subject to placement as per architectural drawings. In all cases, this is the responsibility of the installer.
- Fixings and anchors are not included with the units and are the responsibility of the installer to appropriately fix the unit to the wall.
- Locate fixing position on wall or partition and mark using mounting holes, ensuring the unit is level.
- **2.** Mount the concealed mounting flanges to the wall using appropriate fixings (not supplied).
- **3.** Slide covers over mounting flanges, ensuring the raised edges of the flange lines up with the dimples of the flange cover. Twist and lock into place.
- 4. Check the unit is level to finish installation.

Safety Warning

Ensure that there is proper structure support within the wall. Grab rails are no stronger than the anchors and walls to which they are attached. Grab rails must be firmly secured in order to support the loads for which they are intended.
